In the rare event that the Instructor must cancel the lesson, at least 24 hours notice will be provided and a choice between online instruction, a qualified substitute instructor, rescheduling/ lesson extension or pro-rated refund will be offered. **Termination** a. Either party may terminate this Agreement with 30-day notice. b. If the Student terminates the Agreement prematurely, any prepaid but not yet provided lessons will be refunded. c. If the Instructor terminates the Agreement prematurely, the Instructor will provide a prorated refund for any lessons paid for but not provided. **Practice** The Student agrees to practice regularly, as recommended by the Instructor, to ensure consistent progress.
